In the medical profession, technology is **advancing** so fast that questions of law and ethics cannot be discussed and answered fast enough. Most of these questions involve ending or beginning a human life. For example, we have the medical ability to keep a person technically “alive” for years, on machines, after he or she is “brain dead,” i.e., after the “new brain” has stopped functioning. But is it ethical to do this? And what about the alternative? In other words, is it ethical *not* to keep a person alive if we have the technology to do so? And there are many ethical questions involving the conception of a human baby. *In vitro* fertilization, for example, is becoming more and more common. By this method of conceiving a baby outside a woman's body, couples who have difficulty conceiving a child may still become parents. This possibility brings joy to many families, but it also raises important questions. A fertilized human egg might be frozen for a long time—perhaps decades—before it is implanted in the mother's body. Is this fertilized egg a human being? If the parents get a divorce, to whom do these frozen eggs belong? And there is the question of surrogate mothers. There have been several cases of a woman who is paid to carry (for the nine months of development) the baby of another woman who is medically unable to do so. After

delivering the baby, the surrogate mother sometimes changes her mind and wants to keep the baby.

Whose baby is it? Is it the surrogate's because she gave birth? Or is it the biological parents'?
